RE: **2023 Team Expectations**

**COMMITMENT & COMMUNICATION** – We have committed to work with each player in an effort to maximize their respective softball talents. It is our expectation and understanding that each player, and her parents will maintain their commitment to our softball program. This includes supporting our decisions as to team assignments, position assignments, and coaching judgments made during games and the season as a whole.

We also expect each player to be present at all games and practices unless excused by prior arrangement. Part of your commitment is that you will communicate with the coaches. We can only be successful, and each of our players may only prosper, if we can rely upon one another to maintain this commitment.

**CONCERNS** - If there are any concerns, you should feel free to speak directly to us. Discussion should be limited to your daughter. There will not be discussion about other players. This **MUST** be done away from the team and other families. This **CANNOT** happen during a tournament. We respect and openly welcome questions on why we do what we do. If you need to ask questions this must be done respectfully, professionally, without emotion, and without profanity. Our actions as parents and coaches are a reflection on our program and we expect all to remain respectful to our team, opposing teams, and umpires.

**BIRTH CERTIFICATES & PHOTOS** – At first practice in January, each player in the organization needs to make sure that they have a copy of their birth certificate and a current photograph. These are required in order to allow the player to participate in certain tournaments.

**SCHEDULES** – Tournaments and practice schedules for your daughter’s team will be emailed to you. Practices and games are typically 1-2 days/week in the Winter/Spring and 1 day/week in the Summer. We will play in approximately 5-7 tournaments between spring/summer/fall. Most of the venues will be within 1-2 hours of Plymouth, WI. We may have one out of state tournament each summer.

**PRACTICES** – We will be working on fundamental drills, particularly focusing on throwing mechanics, fielding, sliding, hitting mechanics and base running skills. If your daughter is not a little tired upon returning home from practice, we probably are not doing our job. Throughout the year, we will be demanding of your daughter regarding her effort and her focus on improving fundamental mechanics and mental approach to the game. We have a lot of ground to cover in a very short time, so we very much need and appreciate your efforts to have your daughter at each of the practices. If there is a conflict, we require that you notify us in advance.

**SPORTSMANSHIP** - Our coaches, players and fans will be expected to maintain appropriate behavior at all times during the season. We expect that all in our organization respect their teammates, opponents, their coaches, umpires, fans from their own and opposing teams, and most importantly themselves and the Pumas organization. There are no exceptions to this rule. No profanity will ever be used by Pumas families (parents and grandparents) towards umpires or other organizations. If this occurs, you can and may be removed from this program.

**PHILOSOPHY, PLAYING TIME & POSITION ASSIGNMENTS** – In our program, we attempt to maintain a balance between highly competitive play, having fun, and the player development and opportunity. We do not, however, try to have fun at the expense of learning opportunities. Some of the fun in the game is in having both individual success and team success. Accordingly, there is both a time to mentally focus and a time to play around. As each player moves up through the organization’s teams, the competitive issues are assigned more weight in making decisions. Part of our goal is to build an attitude of continuous improvement in the minds of all the players, and a realization of what it takes to win. This is not accomplished by ignoring competitiveness for the sake of playing time.

*\*We do not promise equal playing time or assignment of a specific position to any player. **Playing time is determined based upon the individual player’s attitude and effort, the coach’s overall assessment of the performance of the player, and the competitive needs of the team.** There is no unimportant position on the field or on the bench. If a player decides to leave the program no refund will be given unless agreed upon by the entire coaching staff of the Pumas program.*
